

**Completion Date:** All work of this RFS will be completed not later than December 31, 2008.


**Method of Compensation:** Lump Sum (As defined in Section V of Agreement.)

**Detailed Scope of Work for RFS No. 2008-03:**

PROFESSIONAL has prepared for and attended the additional Regular and Special Technical Advisory Committee (TAC) and Board meetings described in the attached Table 1 for the purpose of discussing comments, questions, and proposed changes from TAC members for the Draft documents PROFESSIONAL has been preparing under RFS No. 2008-01. These documents include sections of the Basin Management Action Plan and the Seawater Intrusion Response Plan.

The need for certain of these additional meetings was not envisioned when RFSs No. 2008-01 or 2008-02 were prepared. Hence, those meetings were not included in the original scopes of work or budgets for RFSs No. 2008-01 or 2008-02.

The costs associated with preparing for and attending these additional meetings, which were requested by WATERMASTER's TAC, are also shown in Table 1.

Georgina King (GK): Prepare for and attend meeting = 8 hours @ \$145

Total per meeting attended = \$1,160.

Typical cost of meetings attended in person by Derrick only = \$1,436.
